	<p>Exhibitor invitations: If you are not able to submit any of the above-mentioned proofs of your trade visitor status, you may still be eligible to attend the event if you have received an invitation from an exhibitor. The invitation must show the name of the person invited. Please note that exhibitor invitations can only be used when buying tickets and are not valid in combination with a voucher code.</p>

Comments	<ul style="list-style-type: none"> • Without written evidence of your trade visitor status you cannot attend the event. • Please do not come to Nuremberg unprepared! Just writing something down on a sheet of paper at the venue on the day is not possible. • No exceptions will be made, regardless of how many hundreds of kilometres you have travelled. • Only visitors aged 18 and over may attend the event. Exception: trainees aged 16 and above with proof of status. See "Trainees" above. • A verbal confirmation of employee status is not sufficient. • Previous visits to the trade fair do not automatically entitle you to another visit. • Anyone gaining access to the event by providing incorrect information could be liable to prosecution for trespassing as per paragraph 123 of the German Penal Code, e.g. false statement about employment status.
