## Presentations with dogs / cats / other small animals at the exhibition stand

---

### General Information for Exhibitors

Animal protection is very important in Germany and arouses great public interest. Legislation on animal protection is very strict and animals are not regarded as objects, but as fellow creatures that can feel pain and suffering.

Although Interzoo is an international exhibition, the German animal protection regulations also apply to exhibitors from abroad who wish to present live animals at the exhibition.

---

### The well-being of animals has priority over completion of the planned presentation.

The owner(s)/keeper(s) of the animals or the person responsible at the exhibition stand must take all necessary precautions and carry out any necessary measures to ensure the well-being of the animals.

These measures particularly include providing the animals with sufficient food and water. Fresh water must always be available for the animals in a suitable container at the place of the presentation.

Dogs must be given sufficient opportunities for exercise outside the exhibition halls between and directly after the presentations.

The owner(s)/keeper(s) of the dogs or the person responsible at the exhibition stand must remove any excrement left by the dogs on the exhibition site without delay and without being asked.

The owner(s)/keeper(s) of the dogs or the person responsible at the exhibition stand must have all the necessary documents and vaccination certificates available at the exhibition stand.

The organizer reserves the right for special reasons (high temperatures or similar) to prohibit initially approved presentations during the exhibition either temporarily or for the whole remaining period of the exhibition. This shall not affect any official requirements.
