The following terms and conditions shall be deemed to have been accepted upon registration for the event:

1. Registration

Registration for participation in the Congress STADTLANDBIO 2022 is to be done in the Online Ticket Shop. The registration form must be filled out completely and shall be binding upon being sent. The contract shall be deemed to have been concluded upon registration for participation. Please file a separate registration form for each participant. Please do not file any more online registrations after 20/07/2022. It will be possible to register at the event venue.

The ticket is not transferrable.

2. Admittance

Only persons with an industry affiliation will be admitted to the event. All registrations will be reviewed by the organiser on the basis of the information submitted in the registration. The organiser reserves the right to refuse admittance to persons without an industry affiliation and also to subsequently cancel any ticket that has already been sent and to credit the corresponding amount to the invoice. Information on the admittance criteria can be found at https://www.biofach.de/en. For events for which the number of participants is limited, registrations will be accepted in the order of their receipt. Limited participant numbers can result from the available room capacities of the assigned halls or rooms in each case. Despite the most careful planning, full occupancy of individual event parts that may be visited with permanent tickets cannot be ruled out. This circumstance shall not establish a legal right to participation! You will receive your ticket in the email address you indicated in the registration after your registration is received.

3. Vicarious agents

convivus has been engaged by the organiser to perform services related to the organisation, programme coordination and support of participants. In addition, convivus will handle the registration process through its online ticket shops and issue invoices.

4. Cancellation

The ticket is non-cancellable.

5. Exclusion of liability

The organiser shall be liable without restriction only in cases of wilful intent or gross negligence and for damages arising from injury to life, limb or health. This liability limitation shall also apply to the behaviour of the vicarious agents of the organiser. Neither the organiser / print shop nor the publisher shall be liable for defective or omitted reproductions and representations in printed materials or on the website. Liability for the content of advertisements and the reproduction of original third-party texts shall lie exclusively with the respective advertisers or copyright holders. Any claim to damages is excluded.

6. Force majeure, cancellation of the event, programme changes

No responsibility is assumed for programme changes and postponements of events. The organiser reserves the right to change the time or location of events. This also applies to the cancellation of individual programme items. Such changes shall not give rise to a right of rescission for the participant. Any claims for damages on this basis are excluded. The organiser undertakes to inform the participant of any necessary changes as soon as it becomes aware of them. Moreover, the organiser shall not be liable for the presence of announced speakers. If any such speakers should not appear, the participant shall have no claim to damages of any kind. The organiser shall endeavour to remedy any such absence with an adequate substitute. The current status of speakers shall be indicated in the online publication, except in the week preceding the start of the event. Later changes cannot be posted online for technical reasons. The organiser reserves all rights. The rights of third parties shall be preserved.

7. Site regulations

During the event, the participant shall be obliged to observe the site regulations of the organiser throughout the exhibition grounds. Orders and instructions of the employees of the organiser who verify their identity with an employee ID card must be followed.

8. Use of the digital event platform

The participant must register to use the digital event platform in the Ticket Shop of the organiser. After completing the registration process, the participant will receive an email confirming the registration. The participant will receive a link to the event platform talque before the event. The participant or other participants must additionally register on talque to enter and update their digital profile there. The participant may use his or her profile before, during and after the event to communicate with visitors and exhibitors on talque and to utilise services such as video calls, match-making, etc.

9. Data protection information

a) General information

Personal data shall be processed by the organiser as the controller within the meaning of data protection law and where applicable, by our Service Partners, by the service provider Real Life Interaction GmbH charged with the technical implementation of the digital extension, and convivus with due regard to the relevant data protection regulations, in order to support and inform customers and interested parties, to carry out the event, and to provide the offered services (legal basis: Art. 6 para. 1 lit. b EU GDPR). In accordance with the principles of data economy and data avoidance, only the data absolutely required for the aforementioned purposes shall be processed.

Naturally, personal data shall be treated as confidential and protected as best as possible by appropriate security measures. Only authorised persons involved with technical, commercial and customer administration support shall have access to your data. Insofar as legally required, appropriate job processing agreements have naturally been concluded.

Personal data shall be retained only until the contractual relationship with the organiser has ended and the data are no longer required for other legal reasons (e.g., statutory retention periods). Every exhibitor is entitled to lodge a complaint regarding this data processing with the competent supervisory authority for data protection and may demand, subject to the statutory conditions, access, rectification, erasure or restricted processing, object to the processing, or assert his or her right to data portability. b) Information on the use of the digital platform aa) The organiser points out that the data provided by participants upon registration (cf. Item 8) will be processed for purposes of statistical analysis, market research, the provision of information (by mail and email, on future events on similar or related topics), and customer retention measures (e.g., receipt of loyalty benefits, invitation to events) (Art. 6 para. 1 lit. f EU GDPR). This data shall be transferred to subcontractors of NürnbergMesse for processing only for the aforementioned purposes. bb) If the registered participant evinces an interest in or actively participates in a session, roundtable or livestream of an exhibitor or other provider (by clicking on the participation button), his or her data provided upon registration, i.e., last name, first name, company, job title, country, and email address, as well as the duration of attendance of the presentation, shall be transmitted to the respective company or speaker for the purposes of supporting customers and interested parties and providing the

offered services, regardless of whether the company is based in Germany, the EU, or another third country (if the corresponding exhibitor package has been booked). The participant's participation in a session is voluntary and will not take place without further action on his or her part. The data will be transmitted to the company only if the user evinces interest in or actively participates in a presentation. The legal basis is Art. 6 para. 1 sentence 1 lit. b EU GDPR

cc) If the registered participant enters into a mutual interaction with other registered participants in the form of a chat or meeting, a lead list indicating his or her interactions with the participants will be provided to the respective interaction partner of the exhibitor (if the corresponding service has been booked in the exhibitor packages). The lead list consists of the information provided in the registration, i.e., first name, last name, email address, company name, job title, type of interaction (chat or meeting), and country. The participation of the participant in mutual interactions is voluntary and will not take place without further action on his or her part. The data will be transferred to the respective interaction partner only when the user enters into the interaction. The legal basis is Art. 6 para. 1 sentence 1 lit. b EU GĎPR.

dd) If the registered participant retrieves company profiles, the information provided with the registration may be disclosed to the corresponding company (only if the corresponding exhibitor package has been booked), i.e., first name, last name, email address, and duration of the visit to the profile. Visiting company profiles is voluntary and will not take place without further action on the part of the registered visitor or other participant. The data will only be transferred to the company when the user visits the company profile. The legal basis is Art. 6 para. 1 sentence 1 lit. b EU GDPR.

ee) If the registered participant participates in a session, roundtable or livestream, his or her first and last name will be visible to the other participants of the respective presentation. This makes it possible for the participants to network and interact with each other. This is also the legitimate interest of the platform operator (Art. 6 para. 1 sentence 1 lit. f EU GDPR). Naturally, the participant has the right to object to this processing. The manner in which the participant can assert his or her right is regulated in sub-para. ff).

ff) Every registered participant has the right to lodge a complaint against this data processing with the competent supervisory authority for data protection and may, subject to the legal conditions, demand access, rectification, erasure or restricted processing, object to the processing, or assert his or her right to data portability. 10. Applicable law; place of jurisdiction

In this case, however, the organiser shall also be entitled to sue the participant in his or her general place of jurisdiction.

11. Severability clause

If one of the provisions of these general terms and conditions should be or become invalid, the validity of the remaining provisions shall not be affected thereby. The invalid provisions shall be replaced with a valid provision that comes closest economically to the sense and purpose of the invalid provision. The same shall apply to any gaps in the contract.
