**OWNER**

### Approved Documents:

- **Trade licence/extract from Commercial Register** --> Name of owner must be clearly identifiable.
- **Exhibitor invitations:** If you are not able to submit any of the above-mentioned proofs of your trade visitor status, you may still be eligible to attend the event if you have received an invitation from an exhibitor. The invitation must show the name of the person invited.

The exhibitor invitation entitles you to purchase a ticket and redeem a voucher in the ticket shop ([www.iwa.info/en/visitors/admission](http://www.iwa.info/en/visitors/admission)).

### EMPLOYEE

### Approved Documents:

- **Written confirmation** of employment\*, e.g.:
  - **Salary statement/payslip** (confidential information can be blacked out) **or**
  - **Employment contract\*** (confidential information can be blacked out) **or**
  - **Letter from employer\*** on business letterhead or with a company stamp (incl. function within the company and the purpose of visit).

#### Approved Documents:

- 18 years or older: **Written confirmation** of the apprenticeship contract

- 16 - 18 years: Training/apprenticeship contract\* must be submitted.  
In addition, the trainee must be accompanied by an adult.
- No-one under 16 years of age is allowed to attend the event!  
\*Employer/firm must belong to one of the mentioned sectors
