

Info sheet for exhibitors, service partners, service providers, speaker and media representatives at NürnbergMesse about the special hygiene measures in Corona times

The highest priority is given to the health of all persons on the NürnbergMesse site by

- Enabling the respective distance rule
- Ensuring the traceability of contacts
- Feasibility of the "3G"-concept (Visitor access for tested, vaccinated and recovered persons with appropriate proof only)

## Which hygiene rules apply on the NürnbergMesse site during the event?

Visitors: These are all persons who gain access to the event via visitor registration

- → Current specifications of the hygiene concept for trade fairs in Bavaria, currently including
- Visitor access concept: access for tested, vaccinated and recovered persons with appropriate proof only

- FFP2 mask currently still mandatory when indoors
- Minimum distance 1.5 meters
- Ensure contact traceability through registration

Exhibitors, service partners, service providers, speaker and accredited media representatives (so-called "professionals"): These are all persons who are on the event premises in the course of their commercial activity (not: visitors who attend an event in the course of their commercial activity at B2B trade fairs).

## Admission Policy:

- Exhibitors, service partners, service providers and accredited media representatives are
  not required to fulfill the admission concept for visitors (access for vaccinated, tested, recovered
  persons only), but are in their own interest advised to adhere to these guidelines
- Keeping of daily updated personnel lists (retention period: 4 weeks)
- Personalized permanent badges for exhibitors

## Mask requirement:

- Wearing of a medical mask indoors (minimum requirement).
- In outdoor areas / open-air sites: obligation to wear a medical mask if the minimum distance cannot be maintained.
- In cashier and counter areas, the mask obligation does not apply if employees are reliably protected by transparent partitions (see occupational health and safety).
- Transparent partitions can be ordered from NürnbergMesse



**For bloggers and influencers**<sup>1</sup>, the accreditation rules of each event determine whether they belong to the so-called "professionals" or visitors. According to this, it is decided whether the requirements of the German Occupational Health and Safety Ordinance apply to them.

## Which hygiene rules apply on the NürnbergMesse site during assembly and dismantling?

During assembly and dismantling, the regulations of the SARS Cov-2 Occupational Health and Safety Ordinance apply. Among other things, it includes guidelines for wearing a face mask. You can find the applicable regulatory framework here.

The executing company is responsible for the proper implementation and compliance with hygiene protection measures during stand construction activities. For this purpose, a responsible person must be appointed on site to monitor compliance and be available as a contact person at all times. This also applies to all service providers.

Registration is compulsory for assembly and dismantling, as it is for the duration of the trade fair. All persons will be registered and admitted to the exhibition halls by scanning their construction and dismantling passes. Please ensure that all your service providers, such as stand builders, forwarding agents, agency staff, technical service providers, etc., register in advance and have a construction and dismantling pass. This also applies to vehicles entering the exhibition grounds. All occupants must have their own construction and dismantling pass. Please note that persons without a construction and dismantling pass will have to register on site. This may lead to waiting times.

During assembly and dismantling, food is only offered "to-go"; it is taken at the respective stand as the stand builder's workplace - subject to the distance, hygiene and registration requirements applicable there.

Please take responsibility for your employees. Find out about the current occupational safety measures in good time and implement them in the interests of the health of everyone on our exhibition grounds.
