

TEMPORARY IMPORT OF "PROHIBITED FIREARMS AND ARTICLES" FOR EXHIBITION

Dear Exhibitors at IWA OutdoorClassics,

Please check the products you wish to present at IWA OutdoorClassics 2024, including the products of companies present on your stand as co-exhibitors. If any of your products are classified as "prohibited firearms and articles" under the Firearms Act of the Federal Republic of Germany, you need a special licence from the Federal Criminal Investigation Office (BKA), which allows these products to be imported for a limited period of time for exhibition purposes. Please note that since September 1, 2020, new or amended provisions in German weapons law have been in force and must be urgently observed when applying for exemption permits for IWA OutdoorClassics 2024. Therefore, please read the list of prohibited items carefully.

You will receive separate information concerning the presentation of "prohibited firearms and articles" at "Enforce Tac" from 26 – 28 February 2024.

If you are not already in possession of such a special licence (presenting prohibited amounting to firearms and articles specifically at IWA/Enforce Tac 2023) and would like to exhibit "prohibited firearms and articles", please fill out the application for an exemption.

PAYMENT PROCEDURE

Please note that this special licence is issued by BKA and subject to an administrative fee of **EUR 200**, which is payable in advance to **NürnbergMesse GmbH**. If further permissions are requested, please note that each permission will be invoiced separately.

Applications received at short notice and after the deadline (26.1.2024) will be subject to an **express processing surcharge** amounting to EUR 100.

Applications received two weeks before the show (15.2.2024) will be subject to an **express processing surcharge** amounting to EUR 200 (in addition to the normal administration fee of EUR 200).

You will receive an invoice from us as soon as we receive your application. You can pay this fee by bank transfer, credit card or cheque. We will then forward your application and the payment to BKA without delay.

Please note that the process of the permission takes approximately four weeks.


Payment of the administration fee of EUR 200,00 is requested in any case, also when applying for products which are not forbidden.

If the application is withdrawn after submission to the BKA, the administration fee of EUR 200 is also due. Changes after approval will also be charged with EUR 200 administration fee.

A photo or brochure (not a commercial invoice) of the firearms and articles should be enclosed with each application so that they can be classified correctly.

Please note that regardless of the possession of a special licence, military weapons and items according to the German War Gun Control Act (KrWaffKontrG) or any fully automatic firearms are **not** allowed to be exhibited at IWA OutdoorClassics (see enclosed form for detailed list).

Please observe the above-mentioned instructions/requirements as violations will lead to exclusion from the exhibition and may result in prosecution.



Please note

- The permission applies only to use on the stated exhibition stand. If the guns are to be used for demonstration in special areas, this requires special permission from the Federal Criminal Investigation Office and the approval of the exhibition management. Your application for this with detailed reasons must also be submitted to the event management by 26.1.2024 at the latest.
- The quantity is limited to maximum 2 per type or version as the importation of these products is permitted only for the purposes of exhibiting them at IWA OutdoorClassics 2024. Exceptions (larger quantity) are possible, but reasons must be given in the application.
- German exhibitors without BKA approval must state the origin and whereabouts of the firearms and articles in the application for approval.
- Firearms, both military and regular ones, rendered unusable, that have been modified to decorative weapons, are inadmissible for IWA OutdoorClassics and shall not be presented. Aiming devices etc. that shall be presented or demonstrated on guns must not be mounted on firearms rendered unusable but on so-called red guns or blue guns or on plastic replicas because of the new German standards regarding the conversion of firearms to be mere decorative weapons (necessary marking, test and approval by a formal firearms proof house, certification)
- The manufacturer's number must be stated for firearms and articles listed under no. 1-10 and 27-32. If no number is present, it must be marked on the firearm or article.
