\*Note: An additional test is not required if a booster vaccination (third vaccination) can be proven.

# Your visitor access to the event

## Protective measures on site

We offer you a safe space for your business – with on-site hygiene rules to protect all trade fair participants:



1.5 meter safety distance



Hand hygiene (washing and sanitizing)



Follow the rules for coughing and sneezing



Face covering



Refrain from handshakes and hugs



Use contactless payment whenever possible

## What applies to children and young people?

Admission for children and teenagers is subject to the admission regulations of the respective trade fair. Please pay attention to the website of the trade fair\*. Unless otherwise stated, following regulations apply:

- Children under 14 years of age may only attend the event if accompanied by an adult. From the age of 12, registration may be required depending on the event.
- Teenagers aged 14 and over may only attend the event after registration and with their own ticket. Furthermore, they must have the required (Covid) documents for admission.
- Exception for children under 14 years: If they are schoolchildren and are subject to regular testing as part of their school attendance, they are considered to have tested negative and do not need to present additional proof.
- Children under 6 years of age are exempt from all proof requirements.

\*Important notice: Children and young people are generally not admitted to the events IWA Outdoor Classics and Enforce Tac.
